The Housing Authority is located in Terra Linda, one mile north of the Marin Civic Center, on the east side of Highway 101 at the Freitas Parkway/Terra Linda exit, immediately next door to the Sutter Terra Linda Health Plaza. By Automobile

From Sausalito and points South

- Take Highway 101 North and go past central San Rafael.
- Take the Freitas Parkway/Terra Linda exit, one mile north of the N. San Pedro Road exit and the Marin Civic Center.
- Bear to the right where the off-ramp splits off to the right and turn immediately to the right onto Civic Center Drive.
- Turn left at the light onto Scettrini Drive.
- Proceed approximately 100 yards.
- Turn left and go up the driveway where the sign points to “4000 Civic Center Drive” and the “Sutter Terra Linda Health Plaza.”
- At the top of the driveway you will arrive at a level, campus-like parking area.
- Take the second left turn into the parking area and you will be facing the Housing Authority office. It is a low, one-story building with a white stucco exterior and a red tile roof and the address “4020” displayed above the front entrance.
- You may park directly in front of the building in the spaces marked “4020 Civic Center Drive-- Visitor Parking.”

From Novato and points North

- Take Highway 101 South.
- Take the Freitas Parkway/Terra Linda exit, one mile south of the Lucas Valley/Smith Ranch Road exit.
- At the end of the off-ramp, proceed straight through the signal for one short block.
- Turn left at the next signal onto Las Gallinas Avenue.
- Follow Las Gallinas as it curves around the Northgate Shopping Mall.
- At the next signal turn left onto Merrydale Road and go over the freeway.
- At the signal, proceed through the intersection, crossing Civic Center Drive, and go approximately 100 yards.
- Turn left and go up the driveway where the sign points to “4000 Civic Center Drive” and the “Sutter Terra Linda Health Plaza.”
- At the top of the driveway you will arrive at a level, campus-like parking area.
- Take the second left turn into the parking area and you will be facing the Housing Authority office. It is a low, one-story building with a white stucco exterior and a red tile roof and the address “4020” displayed above the front entrance.
- You may park directly in front of the building in the spaces marked “4020 Civic Center Drive-- Visitor Parking.”

By Public Transit

Call Golden Gate Transit for bus routes and schedules at (415) 455-2000, or go online to www.goldengatetransit.org and select "Bus Schedules." The Housing Authority office is located approximately one block uphill from the Terra Linda bus pad on the east side of Highway 101.

For local transportation between the San Rafael Transit Center and the Marin Civic Center and other County offices, including the Housing Authority, you may use the **County Shuttle Connection**. The County Shuttle is available to anyone. It departs from the San Rafael Transit Center (on the Tamalpais Avenue side of the Transit Center) every half hour, on the half hour, between 8:30 a.m. and 3:00 p.m., except for 11:30 a.m., making a round trip to the Civic Center and other County offices and back to the Transit Center. The Shuttle will stop at the Housing Authority office upon request. When boarding the shuttle, simply request that the driver stop at the Housing Authority office at 4020 Civic Center Drive. You should also inform the driver what time to return to the Housing Authority to pick you up. For more information about the County Shuttle Connection, please call CalWORKS at (415) 473-3350.

Special Accommodations

If you are unable to come to the Housing Authority office due to mobility limitations, you may take advantage of one of the following special accommodations:

1. For individuals who meet ADA eligibility criteria, you may call **Whistlestop Wheels** at (415) 454-0964 to arrange for door-to-door para-transit van transportation. Advance reservations are required.
2. The Housing Authority will also be glad to make an appointment at an alternate location that is more accessible to you, such as at one of our residential complexes, or at your home. Please call us at least 5 days in advance of your scheduled appointment to make such arrangements.
3. In many cases we can conduct routine annual re-examinations and other appointments by mail. Contact your Eligibility Worker to inquire about this option.
